



Guideline for abstract submission for National Scientific Conference on Ethiopian Traditional Medicine, 2025

"Towards Evidence based TM integration to Conventional Healthcare System"

Abstract submission format

General content and format

The abstract should comprise of: Title, Author list (highlight the presenter in bold), Affiliations, and Keywords. It should be submitted in Microsoft Word (DOC, DOCX) format only.

Title: The title of your abstract should be concise, and specific. Acronyms or/and abbreviations should not be used. It should be written in Times New Roman with 12 fonts size and bold.

Author list and Affiliations: Authors' full first and last names must be provided followed by their institutional affiliation. The email addresses of the principal author should be provided. The text should be Times New Roman with 10 font size and single spaced.

Body of the Abstract: The abstract should not exceed 400 words. It should be a single paragraph with 12 font, single spaced and Times New Roman. It should follow the style of structured abstracts including; **Background** (highlight the context and purpose of the study), **Methods** (Describe briefly the main methods or treatments applied and statistical tests used), **Results** (Summarize the article's main findings) and **Conclusion** (Indicate the main conclusions or interpretations and potential implications).

Keywords: Provide three to six keywords or short phrases at the end of the abstract page. Separate the keywords using a semicolon.

- Do not insert abbreviations, graphs, tables or references in the abstract section.

- There is a limit of two contributed submissions per author.
- All abstracts must be submitted and presented in English.

- ✓ Herbal drug formulation and pharmaceutical excipients (herbal based)

- ✓ Nutraceuticals
- ✓ Sustainable use of medicinal plants
- ✓ Traditional medicine utilization and practices
- ✓ Computational studies on natural product
